- **a.** Chief Hess updated the board on the status of Station 24. Hoping to have the station open by November. Waiting for new hires to be cleared to drive. Chief Hess would like to hire Home Inspection 360 to come in and do a complete inspection on station 24.
- b. District Chief Bouey gave an update on the refurbished truck. DC Bouey stated that the truck had some blemishes in the paint and needed to be touched up. DC Bouey also stated that the cost of the truck went from \$462,000.00 to \$426,000.00.

#### 7. New Business

- **a.** Board Chairman Bourg stated that we had 2 banks present to discuss bank proposals.
  - i. First Horizon spoke on the offers that they are able to provide to the Fire District. No monthly fees a \$15.00 wire fee, a 3.1% floating interest rate on all accounts.
  - **ii.** Gulf Coast Bank and Trust spoke on the offers that they are able to provide to the Fire District. No monthly fees, 100% FDIC Insurance on all funds, also they provide 100% of the 90 Day T-Bill on all accounts.

Mike Murphy made a motion to leave Hancock Whintey Bank and move all of our funds to Gulf Coast Bank and Trust. John Beyl seconded the motion. Board Chairman Bourg asked for public comment. There was none; motion carried.

- b. Chief Hess stated that we have two insurance agents present to discuss insurance for Fire District 2.
  - i. Ronnie Brabham with Louisiana Insurance, he discussed with the board what his company can offer in coverage for Building and Auto Insurance.
  - ii. Mark Waniewski with Risk Solutions, he discussed with the board what his company can offer in coverage for Building and Auto Insurance.

After some questions from the board to both agents the decision was table for a later date. A special meeting will be scheduled for 10-20-2025 to discuss this matter further.

c. Chief Hess presented the board with a copy of the preliminary budget for 2026. a public hearing and public meeting need to be set to approve the 2026 budget.
